Minutes of 9th Meeting of IQAC, 7th September, 2020

9.1 Welcome address and Introduction

Dr. H.S. Rose, Vice-Chancellor (Officiating) of the University and the Chairman of IQAC welcomed all the new members in the meeting.

9.2 Confirmation of the minutes of 8th meeting of IQAC

The minutes of the 8th meeting of IQAC on 09 January, 2020, circulated to the members and no comments were received on it. The Minutes were approved by the Chairman IQAC.

The committee members discussed the need of engaging the alumni in the academics, student support in addition to mobilization of financial and non-financial resources. As alumni are a brand ambassadors of the university in Industry and society, it was decided to establish a Society for Alumni.

9.9 FDP's, Seminars, Workshops, Conferences, etc.

The Members discussed the need of boosting the academic activities by giving an impetus to Faculty to attend and organize FDP, Seminars, Workshops or Conferences.

9.10 NCC

The Members discussed and appreciated the start the NCC wing in the University. NCC will benefit the students in numerous ways in their career building and education. The University will thus contribute in development of Nation.
